TO CONTROL SPIDERS, ANTS, BROWN DOG TICKS, COCKROACHES, EARWIGS, FLEAS, AND BEDBUGS

DIRECTIONS: Container can be held in any position while spraying, even upside down. For spot or crack and crevice applications only. Do not use as a space spray or broadcast application. Apply directly to pests if possible. If pests continue to be a problem, repeat application as necessary.

FOR INDOOR USES:

SPIDERS, ANTS, COCKROACHES, EARWIGS: Direct the spray into hiding places, cracks, crevices, behind shelves and drawers. For ants, cockroaches and spiders, also spray along door sills, trim openings around sinks, drains and pipes, behind stoves and refrigerators, around window frames, in localized areas around interior walls. For ants, also spray trails, nest and points of entry. Spray directly into cracks, crevices and infested areas of shelving. **FLEAS (ADULT AND LARVAE) AND BROWN DOG TICKS (ADULT AND NYMPHS):** Thoroughly spray infested areas, pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, moldings, window and doorframes. Fresh bedding should be placed in animal quarters following treatment. Allow to dry thoroughly before allowing pets to contact treatment areas. **BED BUGS:** Apply spray directly into cracks and crevices where these pests are found or may hide along and behind baseboards, moldings and floors underneath objects such as the bed and nightstand. Apply directly to insect if possible.

FOR OUTDOOR USES:

SPIDERS AND ANTS: Spray outside surfaces of screens, doors, cockpits, awnings, window frames, light fixtures and other places where insects may congregate on the vessel/vehicle or points of entry. **LIMITATIONS:** DO NOT USE on humans or animals. The application of this product to vinyl and aluminum siding (particularly lightly colored, aged, weathered or otherwise damaged) may result in staining, bleaching or discoloration. Factors such as extreme heat and direct sunlight can promote damage. Before applying, treat a small area of the siding and evaluate 30 minutes later to allow any potential staining to occur. Regardless of the test results, do not apply to vinyl or aluminum siding while exposed to direct sunlight or during the heat of the day. Do not apply to tapestries, wall paper or similar materials that may be stained. For all other surfaces, test a small inconspicuous area of the surface to be treated for color fastness & staining before full application.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat or store at temperatures over 50C. DO NOT USE AS A SPACE SPRAY. Do not use in areas where food is handled, prepared or stored. Wash thoroughly after handling and before smoking or eating. Remove pets and birds and cover fish aquariums before surface applications. After use and at least one (1) hour drying time, wash all surfaces that may contact food. Do not use on humans. Do not allow people or pets to contact treated areas until surfaces are dry. This product is extremely toxic to fish and aquatic invertebrates. Do not apply directly to lakes, rivers, streams, ponds, tidal marshes and estuaries. Do not contaminate the above mentioned aquatic areas through spray drift, cleaning of equipment or disposal of waste.

FIRST AID: If in eyes: hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Have person sip a glass of water if able to swallow. Do not give anything by mouth to an unconscious person. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth , if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: When container is empty, press valve to release pressure. Do not puncture or incinerate. Wrap empty container and discard in household garbage.
